The last date for payment of fees is 16th November, 2024. DETAILS OF FEE & GUIDELINES

- a) Fees: (Per student)
 - i) Registration fee: Rs. 200/- (Registration Rs. 150 + Enrolment Rs. 50)
 - ii) Eligibility fee : Rs. 300/- (Applicable in case of Migrated student)
 - iii) Gap fee : Rs. 300/- (Applicable in case of more than 3 years.)
- The Principal of all the Permitted/Recognized institutions under AHSEC are requested to allow registration only for those students who have passed HSLC or equivalent examination from the Board recognized by AHSEC/COBSE (Council of boards of Schools Education in India). The students who have come from other Board have to submit the original Migration Certificate along with the prescribed fee and statement).
- For smooth management of the entire registration process, only the Permitted / Recognized institutions are allowed to carry out the same. The students who have got admitted through "DARPAN" Admission Portal are allowed to get their names registered through the Permitted/Recognized institutions

- 1. No Offline Registration form will be accepted after expiry of the above mentioned date
- 2. A student can appear for examination only in those subjects given as per registration data.
